IMPORTANT LEGAL INFORMATION CALIFORNIA PROPOSITION 65 (PROP 65)

We import from Europe and distribute our products throughout the United States and Canada, including the State of California. The Safe Drinking Water and Toxic Enforcement Act, commonly known as Proposition 65 (Prop 65), requires businesses to provide a “clear and reasonable” warning before knowingly and intentionally exposing anyone in California to a listed chemical. The California Office of Environmental Health Hazard Assessment has recently made changes to Prop 65 consumer product exposure warning requirements. By no later than August 30, 2018, to qualify for the safe harbor, consumer product exposure warnings must include, among other things, the name of one or more chemicals to which a consumer may be exposed, which are known to the State of California to cause cancer, birth defects or other reproductive harm, or both.

Sealcon sells components that come in package quantities in most cases. The components are not a finished consumer product and the manufacturer doesn't label each part. We do provide information to users of these products which chemicals listed in the current California Prop 65 list are present in which type of product with the expectation that this information will be used to properly label a consumer product using these components. All consumer products should be labeled since it could not be determined if it could ever reach the state of California. Resellers of these components need to pass on this information to their customers.
